Venue: “Theatersaal” of the Austrian Academy of Sciences, 1010 Wien, Sonnenfelsgasse 19, Located in the historical downtown of Vienna not far from Saint Stephens, Vienna’s cathedral and main landmark. See also city plan enclosed.

The venue is best accessible by public transport, underground line 3 (U3), exit at the station “Stubentor”. From there it is less than 5 minutes to walk. But also the underground stations “Stephansplatz” (U1, U3) and “Schwedenplatz” (U1, U4) are nearby.

Hints for paper presenters: All papers are to be presented in English and are to be confined to 20 minutes including discussion. Laptop and beamer for PowerPoint presentations will be available. Just bring your USB-stick. You must not bring your full paper to the conference. Guidelines for publishing your paper in proceedings will be announced at the conference or later.

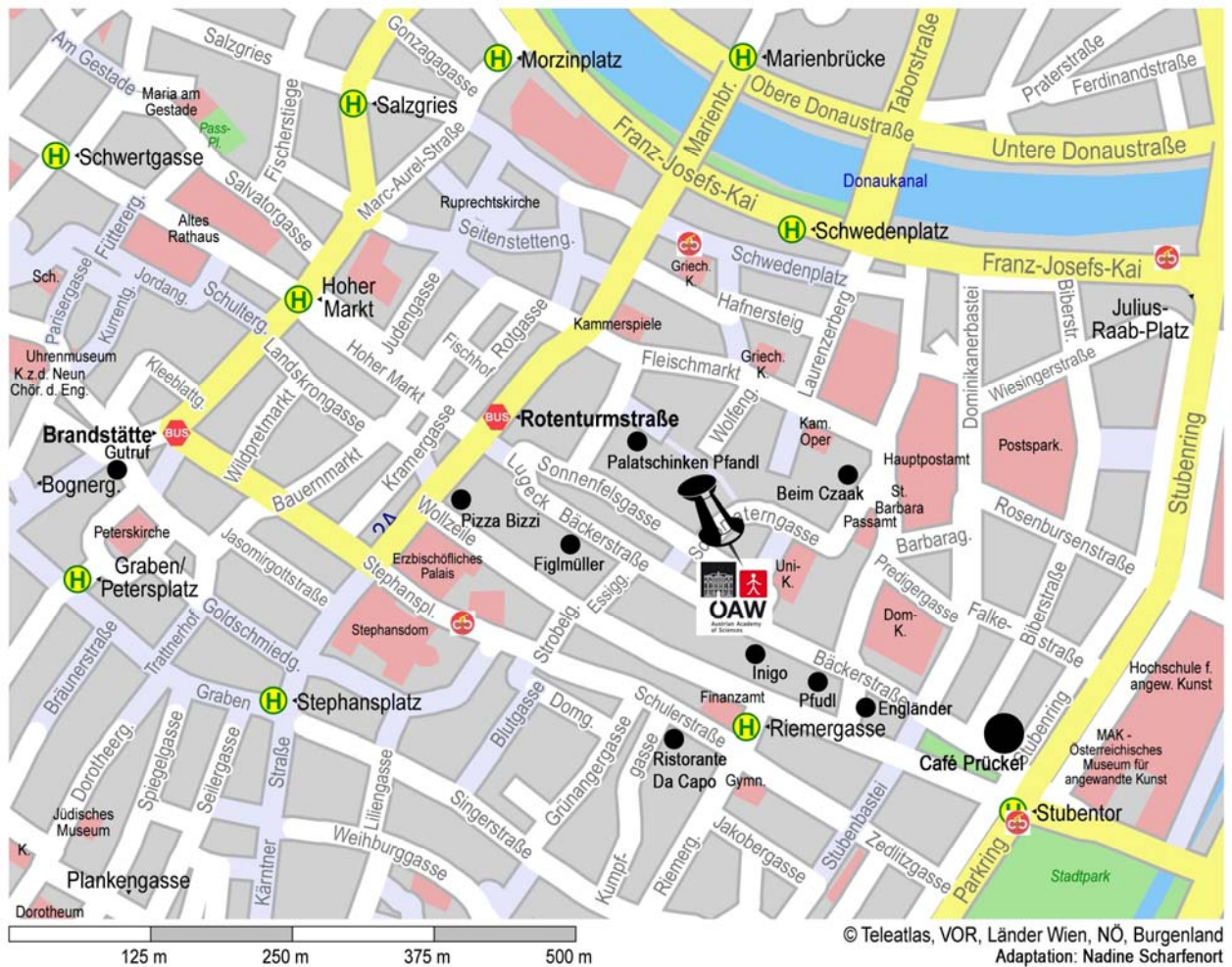
